

## Note to Shareholders

During 2023, Monticello Bankshares, Inc. had continued asset growth through its subsidiary, Monticello Banking Company. This increase was driven by lending activity throughout our expanded market footprint. Our loan generation outpaced deposit growth as demonstrated by our reliance on FHLB and Federal Reserve advances. All the while, the FOMC's war on inflation drove up funding costs which diminished our net interest margin resulting in a lower ROAA than we have become accustomed. Much of the increased funding cost has been absorbed and we expect to see a benefit to earnings through increased asset yields by fye 2024.

MBC depends on our knowledgeable and experienced staff to serve our loyal customer base. The outlook for MBI and MBC remains positive. We will carry the lessons learned through this economic cycle and be better for it as we adapt to this higher for longer interest rate environment.
